NOTICE OF INTENT TO CLAIM OR VARY A DEDUCTION FOR PERSONAL SUPER CONTRIBUTIONS

Section A: Your details

1. Tax file number (TFN)

We are authorised by law to collect your TFN. If you provide your TFN to us, we will use it only for authorised purposes, otherwise, your TFN will be treated as confidential. If you have previously provided your TFN we will continue to use it.

If you have not previously supplied your TFN you may quote your TFN. Under the Superannuation Industry (Supervision) Act 1993, you are not obliged to disclose your TFN. However, if you do not, we are required to deduct additional tax from all concessional contributions made during the financial year immediately prior to the withdrawal. We are also required to deduct tax at the highest marginal tax rate plus Medicare Levy on the withdrawal. An exemption is not considered to be a TFN.
